



# Interstate Seniors (excluding ACT Seniors) Application for a Gold Senior/Pensioner Opal card

**This form is for use by interstate (excluding ACT) Seniors Card holders only.**

ACT Seniors Card holders should NOT use this form but instead apply online at [opal.com.au](http://opal.com.au)

## IMPORTANT

- If you're an interstate pensioner (any Australian State or Territory) holding a Pensioner Concession Card issued by Centrelink or the Department of Veteran Affairs, you do not need to fill out this form.
- You need to attach a photocopy or scan of your Seniors Card (front and back) with this application.
- Following agreement with the Queensland, Victorian, Tasmanian, South Australian, Western Australian and Northern Territory governments to periodically revalidate ongoing eligibility, interstate Seniors Card holders will now receive a Gold Opal card with no set expiry and after initial application, renewal applications will not be required.
- You should submit this application two to three weeks before you need to travel or nominate a NSW delivery address, to allow time for processing and postal delivery. Your application will be processed immediately.
- We recommend that once you receive your Gold Opal card, you register it at [www.transportnsw.info](http://www.transportnsw.info) so you can keep track of your journeys and card balance, set up auto top up and protect your balance if your card is lost or stolen.

## Section A – Conditions of issue and use

To be eligible for a Gold Opal card, you must be the holder of a valid government issued Seniors Card, issued by an Australian State or Territory. **You will need to attach a copy of your Seniors Card (front and back) with this application.**

The Gold Opal card gives you half-fare concession travel in the Opal network (Sydney, the Blue Mountains, Central Coast, Hunter, Illawarra and Southern Highlands), capped at \$2.50 per day. An additional station access fee applies when travelling to or from Sydney Airport Domestic or International stations.

Gold Opal cards for interstate seniors will remain active while you remain eligible for your interstate Seniors Card.

Using the Gold Opal card is subject to the Opal Terms of Use, available at [transportnsw.info/tickets-opal/opal/opal-terms-of-use](http://transportnsw.info/tickets-opal/opal/opal-terms-of-use).

Otherwise we will not disclose your personal or health information unless you consent, or we are permitted or required to by law.

Where TfNSW engages contractors to assist us in providing our services to you, we generally engage them under contract terms that ensure that they use personal information solely for the purpose of fulfilling their contract with us. We also generally require them to manage the personal and health information that they hold on our behalf in a way that complies with NSW privacy laws.
